Hello,

If you are a single parent of a child in your household, you must:

- 1. Provide custody documentation, and
- 2. Complete the attached Child Support Affidavit form (one form for each child).

Acceptable forms of custody documentation include:

- Court documentation stating you have custody 50% or more of the time of your child(ren)
- A letter that is signed, dated, and notarized from the absent parent stating that you have 50% or more custody of your child(ren)
- Most recent IRS tax return showing that you claim your child(ren)
